This new service center maintains an inventory of standard gaskets and stud bolts and boasts state-of-the-art manufacturing capabilities to fabricate special spiral wound, jacketed, Lamons Kammpro[™], corrugated and cut gaskets, as well as stud bolts cut to special lengths, ensuring quick service. Laser technology, as well as CNC plasma-cutting capability, allows the production of intricate heat exchanger gaskets from a single piece construction, including accurately cut cores for Kammpro-type exchanger gaskets.
